### Gift Aid:

What is Gift Aid? Gift Aid is a simple way to increase the value of your base subscription (i.e. excluding any payments for "u3amatters") to Baddow & Galleywood u3a (B&G). If you pay tax in the UK, B&G can reclaim the basic rate of tax on your subscription. For example, a subscription of £12 would be worth £15.00 to B&G at no extra cost to you. Please note that your base subscription only secures membership of B&G and does not secure rights to personal use of any facilities or services provided by B&G.

Do I qualify for Gift Aid? In order for B&G to reclaim the tax you have paid on your subscription, you must have paid income or capital gains tax (in the UK) for each tax year (6 April to 5 April) at least equal to the tax that all the charities or Community Amateur Sports Clubs that you donate to will reclaim on your gifts for that tax year. Other taxes such as VAT and Council Tax do not qualify.
